**110 Henry St:** The owner of 110 Henry Street received a grant to replace a door. The owner wishes to switch the funding from the door to the replacement of two windows.

**Facade and Small Ioan Extensions:** Please recall the RDA placed time limits on most of the grants that were given in 2021 and 2022. The owners of the following properties are requesting extensions to the estimated dates listed:

The total amount of grants awarded in 2021 and 2022 was \$385,152. \$227,274 has been paid to applicants so far.
