## MAY 15, 2023 COMMON COUNCIL MEETING MINUTES CITY OF EDGERTON

Mayor Christopher Lund called the meeting to order at 7:00 p.m.

Present: Shawn Prebil, Casey Langan, Candy Davis, Paul Davis, Tim Shaw and Jim Burdick (remote).

Others Present: City Administrator Ramona Flanigan, City Clerk Wendy Loveland, Municipal Services Director Howard Moser, Police Chief Robert Kowalski, and a few citizens

Loveland confirmed the meeting agendas were properly posted on Friday, May 12, 2023 at the Post Office, Edgerton Library, City website, and City Hall.

**ACCEPT THE AGENDA:** A Candy Davis/Tim Shaw motion to approve the agenda as posted passed, all voted in favor.

**MINUTES:** A Casey Langan/Paul Davis motion to approve the May 1, 2023 Council meeting minutes passed, all voted in favor.

#### **COMMITTEES:**

**Finance Committee:** A Tim Shaw/Candy Davis motion to approve the bills and payroll in the amount of \$262,152.55 passed on a 6/0 roll call vote.

Bonnie Slagg requested the event organizers not be required to pay for the extra port-a-potty. She stated the event was solely funded by donations and felt the donations should go toward purchasing supplies for the kids, not sanitation. The Council explained the current policy stated if an event wanted extra services not currently provided it was at the organizer's expense.

**Library Roof Bids**: Please recall the city rejected the single bid to remove and replace the flat roof at the Edgerton Library in April. Staff readvertised and posted the project on Vendor Net. While we received greater interest, only one bid from the same vendor for the same amount (\$111,064.00) was submitted.

This is an unbudgeted expense. The roof is currently not leaking. If the Council wishes to proceed with the project at this time, funding options include the use of capital surplus funds (current balance \$274,852) or proceeds from the 2022 borrowing. Staff recommends the use of the 2022 loan proceeds as these funds have a time frame in which the funds have to be spent. This would most likely result in future projects either being funded with capital surplus or a delay of a future project.
